## 1. DEFINITIONS

- 1.1 'Lottery Permit Numbers' refer to NSW Permit No.LTPS/18/12601; ACT Permit No.TP 18/00520 and SA Permit No.T18/327.
- 1.2 'AEDT' means Australian Eastern Daylight Time.
- 1.3 'Immediate Family' refers to the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 1.4 'Employees' refer to people employed by VentralP Australia Pty Ltd in any capacity.
- 1.5 'Promoter' means VentralP Australia Pty Ltd (ABN 91 137 543 018) of Suite 105, 66 Victor Crescent, Narre Warren VIC 3805 Australia.
- 1.6 'Promotion' means VentralP Australia's Medieval March 2018.
- 1.7 'Promotion Period' means the entire month of March 2018, commencing on 01/03/2018 at 12:00am AEDT and closing on 31/03/2018 at 11:59PM AEDT for all Australian states.

## 2. PARTICIPANT ENTRY

- 2.1 Entry is open to all residents of Australia except employees and immediate family of the Promoter, associated companies and agencies.
- 2.2 All invoices paid during the promotion period will qualify as a single entry into the draw. The process of entry is automatic once an invoice is paid within the promotion period.
- 2.3 Invoices that have been refunded, cancelled or where payment has not been received will be void and will not be counted as an entry.
- 2.4 Should an entrant wish to withdraw from the promotion (within the promotion period), they will need to contact the promoter via the established support channels as detailed on the promoters website.

## 3. PRIZE

- 3.1 The total prize pool for the winner will not exceed AUD \$7,000.00, with one winner taking a grand prize which includes provisions for the following:
  - (i) Two return airfares from the Winner's nearest capital city to Las Vegas, Nevada, valued at up to \$2,500AUD per person.
  - (ii) 5 nights accommodation at Excalibur Hotel & Casino in a Two Bedroom Luxury Suite (including the resort fee), valued at up to \$1,500AUD.

- 3.3 If a prize is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.
- 3.4 The prize will be fulfilled within 300 days of the draw.

## 4. DRAW PARTICULARS AND DETAILS

- 4.1 The winners of the prize will be randomly drawn from eligible entries as described in condition 2.

- 4.2 The draw will take place at the Promoter's head office located at Suite 105, 66 Victor Crescent, Narre Warren VIC 3805 Australia on Monday, 2 April 2018 at 11:00AM AEST.
  - 4.3 The winner will be notified by telephone, email, and published on the Promoter's website on Tuesday, 3 April 2018.
  - 4.4 The Winner of the prize must sign any release form(s) as may be required by the Promoter (and its associated agencies and companies), and/or any other third party directly or indirectly involved in and with the prize and refusal to sign such form(s) shall result in the immediate forfeiture of the prize and that person shall have no claim, action or recourse at law or otherwise, against the Promoter in respect of the forfeiture.
  - 4.5 A draw for any unclaimed prize will take place at the Promoter's office on Tuesday, 3 July 2018 at 11:00AM AEST. The winner(s) will be notified in the same manner as conditions 4.3..

## **5. CLAIMING PRIZE**

- 5.1 The Winner is not required to be on-site at the draw. Once the Winner is announced, the Promoter will contact the Winner in the manner described in condition 4 to make arrangements for claiming the prize.
- 5.2 The Winner must nominate an ideal date of travel and contact the Promoter within 45 days of the intended travel date. Flights, accommodation, and transfers will be confirmed with the Winner and booked in line with availability.
- 5.3 The Winner must nominate an Australian bank account to the Promoter for an electronic funds transfer to be completed. The Winner must provide, at the request of the Promoter, their nominated Bank Name, Account Name, BSB Number and Account Number within 28 days of the travel date.
- 5.4 If for any reason a winner does not take a prize at the time stipulated by the Promoter, then the prize will be forfeited.

## **6. GENERAL**

- 6.1 Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 6.2 Entrants consent to the Promoter that use of their name, likeness, image and/or voice in the event they are the winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.
