## 1. Definitions

- 1.1. "Lottery Permit Numbers" refer to NSW Permit No. LTPS/18/27202; ACT Permit No.TP 18/01503; and SA Permit No.T 18/1383.
- 1.2. "AEST" means Australian Eastern Standard Time.
- 1.3. "AEDT" means Australian Eastern Daylight Time
- 1.4. "Immediate Family" refers to the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 1.5. "Employees" refer to people employed by VentralP Australia Pty Ltd in any capacity.
- 1.6. "Promoter" means VentralP Australia Pty Ltd (ABN 91 137 543 018) of Suite 105, 66 Victor Crescent, Narre Warren VIC 3805 Australia.
- 1.7. "Promotion" means VentralP Australia's 10th Birthday \$100K Cash Giveaway.
- 1.8. "Promotional Period" means 01/08/2018 at 12:00am AEST and closing on 31/05/2019 at 11:59PM AEST for all Australian states.
- 1.9. "Promotional Stage" means a particular period of time that is associated with a particular prize draw that takes place during the Promotional Period.
- 1.10. "Draw" means the random selection of an entrant to determine the winner of a particular Promotional Stage.
- 1.11. "Prize Draw" means the random selection of a prize during each Promotion Stage.
- 1.12. "Jackpot Total" means AUD \$100,000.00 minus the total combined value of each Prize Draw performed for the first nine (9) Promotional Stages.
- 1.13. "Grand Prize" means the Jackpot Total drawn in Promotional Stage ten (10).
- 1.14. "VentralP Australia" means VentralP Australia Pty Ltd.

## 2. Promotional Period

- 2.1. The Promotional Period will be divided into ten (10) Promotional Stages, commencing and closing on the dates and times (AEST/AEDT depending on the stage) as set out in clause 2.3, for the purpose of determining winners and awarding prizes in this promotion.
- 2.2. Each Promotional Stage will have its own Draw that will be performed at 66 Victor Crescent, Narre Warren, VIC 3805 on the date and time (AEST/AEDT depending on the date) set out in clause 2.4.
- 2.3. Each Promotional Stage will have its own Prize Draw that will be performed at 66 Victor Crescent, Narre Warren, VIC 3805 on the date and time (AEST/AEDT depending on the date) set out in clause 2.4.

- 2.4. The below table provides information regarding the start, end, and draw dates for each individual Promotional Stage.

### 3. Participant Entry

- 3.1. Entry is open to all residents of Australia except employees and immediate family of the Promoter, associated companies, and agencies.
- 3.2. All invoices totalling AUD \$0.01 or more that are paid during the Promotional Period will qualify as a single entry into the Draw. The process of entry is automatic once an eligible invoice is paid within the Promotional Period, gaining automatic entry into the relevant Promotional Stage.
- 3.3. An invoice must be paid within the allocated Start and End times to be entered into the Draw for a particular Promotional Stage.
- 3.4. Invoices that have been refunded, cancelled, or where payment has not been received will be void and will not be counted as an entry.
- 3.5. Should an entrant wish to withdraw from the promotion (within the Promotional Period), they will need to contact the promoter via the established support channels as detailed on the Promoter's website.
- 3.6. There is no limit to the number of entries an individual may have in any particular Draw.

#### **4. Prize**

- 4.1. The total prize pool for the Promotion will not exceed AUD \$100,000.00, with one (1) winner drawn during each Promotional Stage, totalling ten (10) individual winners for the Promotion.
- 4.2. The value of the prize for each Promotional Stage will be determined as set out in clause 5.3.
- 4.3. For each winner drawn in Promotional Stages one (1) to nine (9), the cash prize value will range between AUD \$1,000.00 and AUD \$10,000.00, and will be determined via the manual Prize Draw streamed live on the Promoter's Facebook page.
- 4.4. The winner drawn in Promotional Stage 10 will win the Jackpot Prize, to be calculated and announced during the Stage 9 Prize Draw, as set out in clause 2.4.
- 4.5. Each prize will be provided on a date that is to be decided by both the Promoter and the winner of the prize.
- 4.6. If a prize is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.
- 4.7. Each prize will be fulfilled within 180 days of the Prize Draw.
- 4.8. Each prize must be taken as offered and cannot be varied.
- 4.9. Each prize will be paid in full via a crossed cheque made out to the winner or, if requested by the winner, an EFT transfer made to an account using details provided by the winner.

#### **5. Draw Particulars And Details**

- 5.1. The winner of each Promotional Stage will be randomly drawn from eligible entries, as described in clauses 2 and 3, using an approved random number generator.
- 5.2. Each Draw and Prize Draw will take place as set out in clause 2.2.
- 5.3. The Prize Draw will randomly determine the value of the prize for Promotional Stages 1-9 using a manually-powered spinning wheel, offering an equal 1/10 chance of landing on each of the values set out below.
  - a. AUD \$1,000.00
  - b. AUD \$2,000.00
  - c. AUD \$3,000.00
  - d. AUD \$4,000.00
  - e. AUD \$5,000.00
  - f. AUD \$6,000.00
  - g. AUD \$7,000.00
  - h. AUD \$8,000.00
  - i. AUD \$9,000.00
  - j. AUD \$10,000.00
- 5.4. The winner of the Draw in each Promotional Stage will be notified via direct email and phone call at the time of the Draw, as set out in clause 2.4.
- 5.5. The winner of the Draw in each Promotional Stage will be announced on the Promoter's Facebook page (<https://facebook.com/ventraip>) at the time of each Prize Draw, as outlined in clause 2.4, and will be displayed on the Promoter's website (<https://ventraip.com.au>) for a minimum of 6 months after the Draw has commenced.
- 5.6. The Winner of the Prize Draw must sign any release form(s) as may be required by the Promoter (and its associated agencies and companies), and/or any other third party directly or indirectly involved in and with the prize and refusal to sign such form(s) shall result in the immediate forfeiture of the prize and that person shall have no claim, action or recourse at law

or otherwise, against the Promoter in respect of the forfeiture.

- 5.7. A Draw for any unclaimed prize will take place exactly 3 months after the date of the Prize Draw, as outlined in clause 2.4, with the winner being notified via direct email and phone call at the time of the unclaimed prize draw. Results of the unclaimed prize draw will be published on the Promoter's Facebook page (<https://facebook.com/ventraip>) and website (<https://ventraip.com.au>) on the same date.
- 5.8. All Prize Draws and announcements made during the promotional period will take place under the physical supervision of an Independent Scrutineer.

## 6. Claiming Prize

- 6.1. The winner is not required to be on-site at the time of each Promotional Stage Draw. Once the winner is announced, the Promoter will contact the winner in the manner described in clause 5 to make arrangements for claiming the prize.
- 6.2. If for any reason a winner does not take a prize at the time stipulated by the Promoter, then the prize will be forfeited.

## 7. General

- 7.1. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 7.2. Entrants consent to the Promoter that use of their name, likeness, image and/or voice in the event they are the winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.
- 7.3. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law:
- a. to disqualify any entrant; or
  - b. subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
  - c. The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.
  - d. The Promoter reserves the right to alter or amend these Terms and Conditions, and conditions of operation of the Promotion, subject to the approval of the gaming authorities in each State or Territory, where required.
  - e. Except for any liability that cannot by law be excluded, including the non-excludable guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of:
    - I. any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
    - II. any theft, unauthorised access or third party interference;
  - f. any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable

- I. any variation in prize value to that stated in these Terms and Conditions;
- II. any tax liability incurred by the winner or any entrant; or
- III. use of the prize.
